- 5. Individuals who do not meet the specified criteria for contributions and conditions will be acknowledged in the final "Acknowledgements" section of the article.
- 6. The provisions outlined in this document adhere to the guidelines set forth by the Council of Science Editors (CSE) and the International Committee of Medical Journal Editors (ICMJE).
